## **US SUPREME COURT Denies Soetoro Ballot Challenge**

*At 10:00 am 3-23-15 the U.S. Supreme Court denied my Petition for Certiorari in my **Dummett-Noonan** case.*

*Actually, the Court granted certiorari in only two cases today, and denied certiorari in over 200, so I was in good company. This denial was just posted to the docket sheets in my case. See:*

*The government waived its right to respond to my petition, and the Court did not require it to file a response.*

*It is slightly ironic that on the same day the Court refused to give meaning to the Natural Born Citizen Clause, Senator Cruz announced his candidacy for President. I have looked at this issue extensively, and even though the Cruz camp asserts that he is eligible because he thinks he became a citizen as of the moment of his birth under applicable law (?) --- and he thinks this satisfies the constitutional test, IT DOES NOT! The natural born citizen clause demands that there be NO ALIEN ASPECTS TO A CITIZEN'S BIRTH. One cannot be "alien" and "natural" at the same time.*

*And in addition, there is still the question of whether or not Mr. Soetoro is a U.S. citizen. He was born in Kenya to a minor child (only 18) who failed to achieve the age of 19 to be considered capable to transfer American citizenship to a child fathered by an adult foreign alien. I, Edward C. Noonan declare that Mr. Soetoro had the opportunity to prove his citizen in our court since 2012. He failed to do so and therefore the time is over for him to prove his citizenship. The lack of citizenship charges were not address and instead, the court ruled that no one had the duty to enforce the U.S. Constitution.*

*Today is a sad day for the former United States of America. We do not have a legitimate POTUS, nor legitimate SCOTUS nor a legitimate Congress.*
