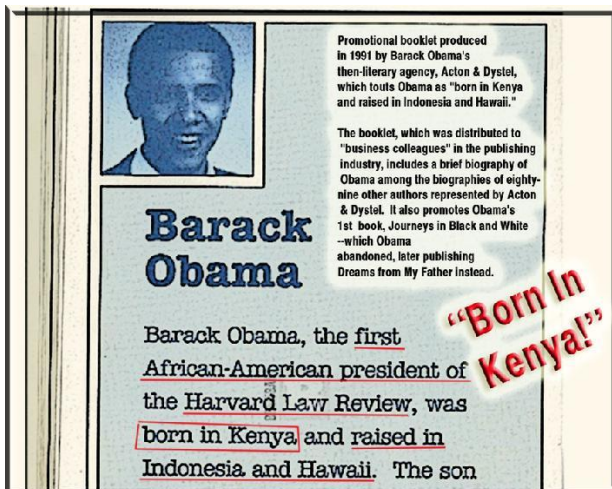

BARRY SOETORO Still "Looking for his Birth Certificate"

(Left) This, of course, was in direct opposition to his 1991-2007 author's biography that stated he was "BORN IN KENYA."

Mr. Soetoro had the opportunity to prove in a court of law that he was a U.S. citizen. He refused to do so. He was charged in court documents that he had committed a crime: In the *NOONAN vs. Debra BOWEN, CA Sec of State* case:

The Court refused to obey the California Constitution which states what Judges are supposed to do about the felonies which Soetoro (aka BHO) was being charged with:

ARTICLE 1 DECLARATION OF RIGHTS :

SECTION 14. **Felonies shall be prosecuted as provided by law**, either by indictment or, after examination and commitment by a magistrate, by information. **A person charged with a felony by complaint subscribed under penalty of perjury and on file in a court in the county where the felony is triable shall be taken without unnecessary delay before a magistrate of that court.**

Barry Soetoro (aka BHO) was charged in the court documents filed by Edward C Noonan, (2012 Presidential candidate, and Founder and National Committee Chairman of the [American Resistance Party](#)) with criminal felonies of forging a birth certificate to gain a political office. The Judges (Superior Court, Appeals, CA Supreme and US Supreme Courts) refused to comply with the California Constitution.

The California Constitution states:

ARTICLE 1 DECLARATION OF RIGHTS :

SECTION 3. **The people have the right to instruct their representatives, petition government for redress of grievances,** and assemble freely to consult for the common good.

The courts ruled that Edward C Noonan "did not have standing" to bring a suit before the court. This is in direct violation of the California Constitution which states ALL CITIZENS have a God-given right to petition ANY PART OF THE GOVERNMENT FOR REDRESS OF "ANY" GRIEVANCE. This includes petitioning the courts!

The court ruled instead, saying the Secretary of State did not have a DUTY to uphold the Constitution.

Mr. Soetoro can smirk all he wants about "looking for his birth certificate" but the fact remains that he has failed to prove that he is a citizen of the U.S.A. in court!
