**May 25, 2015 – Jonathan David Mooers writes: HAPPY MEMORIAL DAY - Attached are pics of my Dad (1944) and I (1973) during active duty. And he writes:**

*Before Dad died at age 80, he mentioned that flying as a tail-gunner in the back of lumbering B-24 bombers, while manning twin 50-caliber machine guns, was terrifying over German drop zones. With anti-aircraft fire bursting all around the craft at times, he said you either go nuts or try to relax and resign yourself that your life is completely in God's hands.*



*When one thinks of all the terror, inconvenience, wounds, death, boredom and severe trials American servicemen and women have endured since our nation was fought for and formed, one might also ask how did America in 2015 get in such a divided and debt-strapped condition via unaccounted lawlessness.*
