CLIVEN BUNDY Arrested for following Constitution!

February 11, 2016 – The corrupt Establishment-<u>USA-News</u> reported today, <u>"Oregon protesters set to surrender; Nevada rancher Cliven Bundy arrested."</u> However the collaborators at USA News refuse to tell the true story. These are the true facts:

Twenty-one years ago (1995), rancher Cliven Bundy stopped paying his unconstitutionally levied grazing fees by the unconstitutional Bureau of Land Management (there is no mention or authorization in the Constitution for the creation of a Bureau of Land Management).

Because of the unconstitutional aspect of the BLM's demands, Bundy did not recognize federal authority over land where his ancestors first settled in the 1880s, which he claims belongs to the state of Nevada. The Bureau of Land Management disagreed and took him to the corrupt federal court, which first ruled in favor of the BLM in 1998. After years of attempts at a negotiated settlement over the unconstitutional \$1.2 million that the BLM demanded from Bundy, federal land agents began seizing hundreds of Bundy's cattle legally grazing on his public lands that had been in his family since 1880.

The American Resistance Party stands 100% with Cliven Bundy and LaVoy Finicum. The US Federal Government has violated the US Constitution (for over 150 years) and fails to comply with Art 1, Section 8, Clause 17 (Powers of Congress) which mandates:

To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the acceptance of Congress, become the Seat of the Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock-Yards, and other needful Buildings;

Both Bundy and Finicum have long held that the constitution forbids the Federal Government from holding any state property except for MILITARY purposes.

And in addition we have an unconstitutional Federal Reserve System that is NOT a Federal agency. It is an international banking cartel that has been given control to our public funds and printing of our money. Does not our constitution say that only Congress has power over our money, "To coin Money, regulate the Value thereof, and of foreign Coin, and fix the Standard of Weights and Measures;..."

Art 9 limits the Federal government to force states to accept illegal aliens: "Art I - Section 9 - Limits on Congress: "The Migration or Importation of such Persons as any of the States now existing shall think proper to admit,..."
