**MERRICK GARLAND  
Anti-Birther SCOTUS Nominee**

March 19, 2016 – The [American Resistance Party](#) condemns the choice of Merrick Garland as a choice for a justice on the US Supreme Court. Garland, 63, is currently the chief judge of the U.S. Court of Appeals for the D.C. Circuit.

Garland is well aware that there have been serious challenges to the eligibility of Mr. Soetoro (aka BHO). [The news](#) has reported on the ballot challenges for over 7 years:

*“It would be even more disruptive, however, if ~~p~~President Obama (Soetoro) were deposed because the Supreme Court held that he was born in Kenya, or if the federal tax code were held unconstitutional, or if people could immunize themselves from the law by declaring themselves “sovereign citizens.” If the mere fact that a plaintiff raises a potentially disruptive legal argument were grounds for removing all obstacles to immediate Supreme Court review, **then the Court’s docket would be clogged with cases brought by birthers**, tax protesters and sovereign citizens.”*

Garland has been well aware of the **FEDERAL CASES** against Soetoro (aka BHO):

Berg v. Obama (2008); Essek v. Obama (2008); Kerchner v. Obama (2009); Barnett v. Obama (2009); Hollister v. Soetoro (2009); Cook v. Good (2009); Rhodes v. Macdonald (2009); Taitz v. Obama (2010); Taitz v. Astrue (2011); Taitz v. Ruemmler (2011); Archibald v. U.S. Department of Justice (2011); Sibley v. Obama (2012).

These cases challenged the eligibility with the following charges:

- A case/complaint challenging that Obama was born in Kenya, not Hawaii, and was therefore a citizen of Kenya or possibly Indonesia, where he lived as a child.

- *A complaint objecting to the grounds that Obama was not a natural born citizen based on allegations that Obama was born in Kenya.*
- *A complaint objecting that Congress failed to verify Obama's eligibility.*
- *A complaint challenging that Obama is ineligible for office and an injunction to void his actions and appointments as President.*
- *A complaint against Barack Obama (referenced as "Barry Soetoro", in regards to the name given at the time of BHO's enrollment in an Indonesian elementary school.*
- *A military officer seeking a temporary restraining order and status as a conscientious objector, arguing that his deployment orders were invalid because Obama was not a natural-born U.S. citizen, and therefore ineligible to serve as commander-in-chief of the armed forces.*
- *A military officer objecting to deployment orders which were illegal since Obama was illegally serving as President.*
- *An attorney's Propria Persona ballot challenge filed as a petition for writ of quo warranto (a writ or legal action requiring a person to show by what warrant an office or franchise is held, claimed, or exercised).*
- *A court challenge to force a FOIA to grant access to Obama's "long form" birth certificate.*
- *A court challenge to force a FOIA seeking "information regarding Obama's birth in 1961, family background, citizenship, residency, immigration, expatriation/repatriation, and other matters related to Obama's origins and nationality generated during the FBI's 2008 investigation of presidential candidates"*
- *A Federal court challenge alleging that BHO is not a natural-born citizen and that his birth certificate is a forgery.*
