I reviewed your email data. I was/am totally amazed at your total lack of understanding of the true question in this matter.

You wrongly pick as your first QUESTION #1 as being: **"...how can the Obama 'birth certificate' state he is "African-American"?"**

This shows to me that either you wish to deceive your reader(s) or else you have totally “missed the boat” about what this issue is all about!

So in just a few pages I will explain the simple question you “should be asking” and then you will understand what the real question really is, and you can easily know if you are FOR THE CONSTITUTION OR AGAINST THE CONSTITUTION.

First of all, it is NOT a “birther” issue. What it is is a CONSTITUTIONAL ISSUE.

Our constitution states that the PRESIDENT of our nation SHALL BE A NATURAL BORN CITIZEN. I was taught in high school (50 years ago) that a natural born citizen was one that had nothing in his birth that was “alien.” In other words, you could not be POTUS if your father or mother were aliens, nor could you be POTUS if you were born in an alien country. Is it really this hard to understand this constitutional mandate? How can you be NATURAL if there is something ALIEN in your birthing?

So here we have a half white, half Marxist-gay black guy showing up and claiming to be a NATURAL BORN CITIZEN.

My case stated:
