My attorney (Nathaniel Oleson of the United States Justice Foundation) has just sent me a pre-copy of the Opening Brief of our CA Appeals Court case against Debra Bowen, CA Secretary of State and against Mr. Soetoro (aka illegal alien/de facto POTUS). In this brief we state that the court has done us a great injustice by denying us justice. We were slapped down with no discovery, no subpoena power, no fair hearing, and no legal remedy to challenge an illegal alien that has usurped the office of POTUS and Commander in Chief. But by their denial, they have stated that all of the facts we had challenged Soetoro on, IS TRUE! This is how the law views it (and we argue it in our case):

Because this appeal arose from the lower Court's sustaining a demurrer to FAP without leave to amend, the issue is whether PETITIONERS stated, or could state, a cause of action under any possible legal theory. For such purposes, all material facts pleaded in the complaint, and those that arise by reasonable implication, must be considered true. *Pollack v. Lytle* (1981) 120 CA3d 931, 936, fn. 2 (disapproved on other grounds as stated in *Beck v. Wecht* (2002) 28 C4th 289, 298).

Since the court, Soetoro and the Secretary of State refused to give us a fair hearing, they basically AGREED THE FACTS WERE TRUE, but they chose to fight their case instead on technicalities.

The following points were brought up in our original BALLOT CHALLENGE/WRIT OF MANDATE:

- 1) Soetoro is his true name... he was adopted by Lolo Soetoro and changed his name. Soetoro (aka was elected under an alias name of Obama).
- 2) Soetoro (aka Barack Obama) was born in Kenya.
- 3) Soetoro is not a natural born citizen. His birth father was not a citizen of the United States
- 4) Soetoro's mother was a minor and was not legally able to transfer US Citizenship to her child. The father, an adult from Kenya gave his citizenship to his son. Both British citizenship and Kenyan citizenship passed to Soetoro as a baby.
- 5) Soetoro (aka BHO) forged a U.S. birth certificate. Soetoro cannot prove he is a U.S. citizen let alone a NATURAL BORN CITIZEN. An extensive number of pages from Sheriff Arpio's Cold Case Posse of Arizona were submitted in our original court records.
- 6) Soetoro forged a Selective Service registration card.
- 7) Soetoro stole and is still currently using the social security number of a man that was born in 1890. Soetoro has used dozens and dozens of other stolen social security numbers during his life as an illegal alien.
- 8) Soetoro and the Democrat National Committee Chairwoman forged and altered the paperwork confirming his qualifications to be eligible for the office of POTUS.
- 9) Soetoro has never been properly vetted by the US Congress.
- 10) Soetoro has managed to weasel out of over 400 legal cases challenging his qualifications to be heard by the courts. Not a single case has ever reached discovery or been given subpoena power. The courts have been as corrupt as the White House and the Congress.
- 11) No US passports can be found for his 1981-1991 travels to Indonesia, Pakistan, Russia and Kenya. He used passports as a citizen of other countries to enter these foreign nations.
- 12) The military has also been AWOL in giving legal review to the qualifications of their Commander in Chief. LTC Terry Lakin went to Leavenworth prison so the illegal alien in WH "wouldn't be embarrassed" (that is the reason why the Court Martial Judge gave for not allowing Lakin discovery and a fair hearing at his Court Martial).

Instead, a military kangaroo court railroaded Lakin and sent him to prison.

SO, SOETORO, THE COURT, AND THE SECRETARY OF STATE all agree the above is TRUE. Not once did they make any rebuttal on any of the above charges. Let me restate the legal point in law...

**WHENEVER A COURT SUSTAINS A DEMURRER WITHOUT LEAVE TO AMEND...THEN ALL MATERIAL FACTS PLEADED IN THE COMPLAINT MUST BE CONSIDERED TRUE!**

In the case above, neither the court, nor Soetoro, nor the Secretary of State addressed/denied any of the CHARGES... they merely stated they didn't have the desire or DUTY to check the qualification of their favorite PRESIDENTIAL CANDIDATE (Soetoro).

Hence our contention, that since they did not reject or answer our charges, then they agreed that our charges were true.

As soon as the FINAL version of the Opening brief is filed, I will post a copy of it online. Since then, I would urge all who read this post to understand that ALL 400 CASES THAT HAVE BEEN FILED SINCE 2008 ARE TO BE CONSIDERED TRUE IN FACT...and all have been dismissed at the whim(s) of (a) corrupt judge(s).
