However, we offered Mr. Soetoro (aka BHO) a chance to address this birth certificate in our court case that started in the Sacramento Superior Court, went through the Appellant Court, the CA Supreme Court, and finally the US Supreme Court. We claimed he was born in Kenya. We also challenged Soetoro with several of his felonies. In California one of the Declaration of Rights is that, "Sec 14 - Felonies shall be prosecuted as provided by law, either by indictment or, after examination and commitment by a magistrate, by information. A person charged with a felony by complaint subscribed under penalty of perjury and on file in a court in the county where the felony is triable shall be taken without unnecessary delay before a magistrate of that court..." "Our case was dismissed. The corrupt judges stated that the Secretary of State of CA had NO DUTY TO UPHOLD THE

CONSTITUTION. (Art II). So our case was trashed without a fair hearing or being allowed to offer evidence or allowed discovery.
