The [American Resistance Party](#) has many questions about your legal right to be a California State Senator. I question your U.S. citizenship!

CBS published an article titled, “Senate Leader: ‘Half of My Family’ Eligible For Deportation Under Trump Order.” The article quoted you by saying:

California Senate Leader Kevin de Leon made the claims during testimony before the Senate’s Public Safety Committee for SB54, a bill introduced by De Leon that would create a statewide sanctuary for immigrants living in the country illegally.

“That’s what you need to survive, to work,” he added. **“They are eligible for massive deportation.”**

"The untold story of how Kevin Leon became Kevin de León." It was dated, February 21, 2017. They wrote, "The name on his birth certificate isn't Kevin de León.

"That's how the Los Angeles Democrat identified himself more than two years ago when he was sworn in as the 47th president pro tem of the California Senate, the first Latino to hold the position in more than a century."

"On his birth certificate and voter rolls, however, the 50-year-old politician is **Kevin Alexander Leon.**"

In this same article you claim your mother and you floated back and forth across the border during your childhood years:

"Hardly anyone knows this story," de León told The Sacramento Bee recently. He agreed to do an interview over dinner after The Bee asked about his name.

The certificate says he was born on Dec. 10, 1966, at California Hospital on South Hope Street in Los Angeles.

It describes his father, Andres Leon, as a 40-year-old cook whose race was Chinese and whose birthplace was Guatemala. De León's mother, Carmen Osorio, was also born in Guatemala, the document states. She was 26 when he was born.

As a child, de León spent time on both sides of the border, in Tijuana, Baja California, and Logan Heights in San Diego and identifies strongly with Mexican culture, though he doesn't know where his grandparents are from. He didn't know his father, Andres, but remembers meeting him as a boy. De León said he didn't ask his mother about him in the ensuing years, believing that "ignorance is bliss. You don't know what you don't know," de León said.

You seem to be claiming to be a U.S. Citizen FROM BIRTH! If this is indeed true, did you register for the Selective Service when you turned 18 (1984). This would have been just after you graduated from McClatchy High School in Sacramento. The Federal law reads:

"...all males between ages 18 and 25 must register with the Selective Service System (SSS) within 30 days of arriving in the United States. This includes U.S. born and naturalized citizens, parolees, undocumented immigrants, legal permanent residents, asylum seekers, refugees, and all males with visas of any kind which expired more than 30 days ago."

I am suggesting that you were a 'birthright baby.'" Your mother came across the border as an illegal Mexican citizen and you were born. You suggest that your mother obtained a **false social security card, they got a false identification, they got a false driver's license and could have been**

deported. This hardly suggests one that is UNDER THE JURISDICTION of the United States Government. Did your mother ever file a tax return? Did you file a tax return as soon as you turned 18? If you are a birthright baby... did you honor that birthright AND BECOME A GOOD CITIZEN.

The above Bee article states that, “De León’s mother, now deceased, was among the undocumented members of his family.”

At what point did any of your family become SUBJECT TO THE JURISDICTION of the United States? (14th Amendment “All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside.”)

I was especially irritated at the YouTube video that was posted for a few years (2006) showing you disrespecting the US National Anthem while on stage, but you snapped to attention and saluted when the Mexican Anthem was played. <https://www.youtube.com/watch?v=FgbCB8QIQWw> That video shows that you are a citizen of Mexico and hate the United States!

You do not seem to know what a citizen is! This is the definition:

“A native or naturalized member of a state or nation who owes allegiance to its government and is entitled to its protection (distinguished from alien).”

You have consistantly failed to SHOW ALLEGIANCE to California and the U.S.A.

42 USC Sec. 15544

TITLE 42 - THE PUBLIC HEALTH AND WELFARE
CHAPTER 146 - ELECTION ADMINISTRATION IMPROVEMENT
SUBCHAPTER VII - MISCELLANEOUS PROVISIONS
Sec. 15544. Other criminal penalties

(a) Conspiracy to deprive voters of a fair election

Any individual who knowingly and willfully gives false information in registering or voting in violation of section 1973i(c) of this title, or conspires with another to violate such section, shall be fined or imprisoned, or both, in accordance with such section.


(b) False information in registering and voting

Any individual who knowingly commits fraud or knowingly makes a false statement with respect to the naturalization, citizenry, or alien registry of such individual in violation of section 1015 of title 18 shall be fined or imprisoned, or both, in accordance with such section.
