On 8/15/17, Edward C Noonan, the American Resistance Party's Founder and National Committee Chairman received the following email:

U.S. Attorney Boente:

I request you assign an assistant U.S. attorney to impanel a federal grand jury in Knoxville or Chattanooga (my preference is Knoxville) to investigate matters I'm prepared to witness upon, proffer proof about and give testimony consequent my standing criminal complaints and written, sworn reports.

State and federal government officials, judges have so far successfully blocked me from appearing before a constitutionally recognized state and federal grand jury.

Most recently, McMinn County Criminal Court Judge Sandra N.C. Donaghy blocks me from advancing my testimony and evidence to the McMinn County Tennessee county grand jury, which I attempted last month, on Tuesday, 18 July 2017. I fully recognize and appreciate Donaghy's criminal obstruction of justice and allied state and federal criminal acts for what they are.

*U.S. Attorney General Jeffrey Sessions received My 26 July **2017 formal, sworn criminal complaint naming Robert "Bob" Swan Mueller, III in commission of TREASON** and lesser included offenses on 28 July 2017. The 26 July 2017 complaint names other government officials. It also extended and renewed **seven (7) additional TREASON** complaints dating back to and filed since 17 March 2009. **The seven other formal TREASON complaints** were filed with you in February 2017.*

I filed another formal, sworn criminal complaint with many federal agencies on 3 March 2017. I filed the 3 March 2017 criminal complaint with you. The 3 March 2017 is connected directly to, what **now counts to eight (8), separate TREASON complaints.**

I've attached the **26 July 2017 TREASON complaint,** once again as a .pdf record, offering ready access and reference.

Three developments in the past week impel this communication to you today:

(1) Tuesday, 9 August 2017: The first YouTube recitation of the 26 July 2017 published just before 1900 hours EDT and spreads like a wildfire,

(2) Wednesday, 10 August 2017: Nearly exactly twenty-four hours after the YouTube presentation, I find New York Representative (4th District, Long Island) New York declaring me, once again, a "Domestic Security Threat." I am, like Mrs. Dana Loesch and tens of thousands of others, a member of the National Rifle Association (NRA).
