Supposedly the US Supreme Court ruled (*United States v. Robel* 389 U.S. 258 (1967)) that Communists have a "constitutional right" to interfere with the US Government. The court ruling was complete gibberish and made no sense at all. They held: "Section 5(a)(1)(D) is invalid since, by its overbreadth, it unconstitutionally abridges the right of association protected by the First Amendment."

**And this is what Section 5(a)(1)(D) states:** "Employment of Members of Communist Organizations -- Sec. 5. (a) When a Communist organization, as defined in paragraph (5) of section 3 of this title, is registered or there is in effect a final order of the Board requiring such organization to register, it shall be unlawful- (1) For any member of such organization, with knowledge or notice that such organization is so registered or that such order has become final- (D) if such organization is a Communist-action organization, to engage in any employment in any defense facility.

**The Constitution requires our government be a "Republican form" of government.** (*The Republican Form of government is one in which the powers of sovereignty are vested in the people and are exercised by the people, either directly, or through representatives chosen by the people, to whom those powers are specially delegated.*) **Communism is NOT a Republican form of government. Trump errors in making deals with commies!**
