After reading this online article, Edward C Noonan, Founder of the American Resistance Party wrote this following response:

*I read this article and am at loss that my church (LDS) would go against the Utah Constitution. The article implies that my church implies (in the article) **"The Church of Jesus Christ of Latter-day Saints and seven other religious organizations say in the brief that they accept same-sex civil marriage is the law of the land."***

And finally, may I point out to the leaders of my church this signature block found at the end of the UTAH CONSTITUTION. It says, **"Done in Convention at Salt Lake City, in the Territory of Utah, this eighth day of May, in the year of our Lord one thousand eight hundred and ninety-five, and of the Independence of the United States the one hundred and nineteenth."**

"The LORD" as mentioned here, of course, is Our Lord and Savior Jesus Christ, the son of God. Right?!
