Dear Ms. Harris:

I have read with interest a letter penned by Gary M. Wilmott concerning your ineligibility to run for POTUS. I agree with him that both of your parents were aliens prior to your birth. It is my contention that you cannot be natural born, as mandated by Art II (US Constitution) if your parents were non-citizens after your birth.

There is one point of his letter that I disagree with. It is his use of the title, “Senator” next to your name. There is no way you can be a Constitutional Senator. You have successfully destroyed the Constitution and it is dead.
