New York Attorney General Eric Schneiderman (D) is collaborating with a radical abortionist and an avowed communist to attack the free speech of pro-life people. This concerted attack is truly outlandish — and potentially quite dangerous.

The AG filed a federal lawsuit against 13 people who protested outside a Planned Parenthood abortion clinic. He is seeking to silence pro-lifers and Christians while working with at least two fringe radicals in this legal assault. Liberty Counsel is defending one of the thirteen defendants.

+ + New York's top law officer says "no free speech."

After filing the lawsuit, AG Schneiderman made an absolutely unbelievable statement by declaring, "We are not a nation where you can choose your point of view."

Mr. Schneiderman, expressing your point of view is exactly what the First Amendment protects. And in this case, whether pro-life or Christian, those viewpoints are constitutionally protected!

+ + A radical pro-abortionist says "taking life" is OK.

In one of the most outrageous statements I've ever heard, Merle Hoffman, president and CEO of Choices Women's Medical Clinic (Choices) in New York, testified that the "act of abortion positions women at their most powerful" because abortion gives women "power-and the responsibility-of taking life" so that they may control their own lives. (Emphasis added)

Then, concerning pro-life advocates, she added, their "mere existence ... is a crime against women."

+ + An avowed communist seeks to silence pro-life people ... and overthrow the government!

When she is not planning and advocating for a violent revolution to overthrow the United States government by force, Mary Lou Greenberg, spokeswoman for the Revolutionary Communist Party, USA, is the director of the "escort program" at the Choices Women's Medical Center.

It was in the latter capacity that AG Schneiderman has been working with Greenberg to gather "evidence" against the pro-life defendants. Inexplicably, Schneiderman has been quite willing to overlook Greenberg's seditious speech and advocacy while eagerly prosecuting peaceful Americans whose pro-life speech he finds deplorable.

These are the Far-Left abortion advocates that AG Schneiderman is collaborating with to shut down free speech in his state! As I've said prior, the secular radicals will become even more aggressive and unhinged this year. Be prepared for an all-out war!
