Upon looking over the duties of election officers in Kern County, California, I didn't see any information on Paper Ballots.

As an elections office inspector, I felt it was my duty to make sure Paper Ballots were going to be provided as the manual gave no indication if they would be.

The elections, Poll Worker Training Manual provides information on setting up the Touchscreen Units and Polling Sites but I found nothing regarding Paper Ballots.

I have not participated in the training class as yet, I'm scheduled for May 30, 2018 for my training. But reviewing the information provided thus far, I wanted to get a jump on it, before May 30, in case Paper Ballots was not going to be provided, we could change that.

I called the Secretary of State, Elections Division, at (916) 657-2166 and spoke with Rodney Rodriguez who told me "he had no idea, I would have to check with the person in charge of elections in my county."

I then asked "wouldn't that be the state of California's responsibility since voting was a right that the state was charged with protecting"?

Mr. Rodriguez's response was "yes but to call the county elections clerk."

I then asked "if the county election clerk didn't know, then I should call him back"?

Mr. Rodriguez then said "yes, absolutely, because then that would be a serious problem."

Calling my county's election precinct, I found they had no idea, that all the material needed was supplied by a third party.

Now, calling the County Clerk I learned that Paper Ballots are provided, and the Touchscreen Unit's are there for the disabled. She further stated most people use the Paper Ballots and then went into a speech about the Units and that each Precinct had one and a back up Unit, blah blah blah.

My overall take on this inquiry was; not one person I spoke with, was forthcoming on the information I was requesting. Answers had to be pulled out of them. Further, the manual indicates touchscreen(s) not touchscreen as I was led to understand.

And unless I'm not thinking this through enough, the 3 clerks for my precinct, are there to assist those that need assistance and an ADL officer that sets up booths for the disabled.

So, I'm not confused, just leary that I was being given incorrect information, to protect their arse's.

I will be on high alert on election day.

There was a long period of silence before Mr Rodriguez answered each question. His first responses were vague, so that I had to press further.

When I requested his name in case I found it necessary to call him back, he then wanted my name as well.

It may be a very important task that at least one person should inquire into for their county, and if capable to cover several counties, that would be awesome.

We have 58 counties in California and as we all know, they claim we are a BLUE state, through and through, but my research says otherwise.
