

**DR. CHRISTINE BLASEY FORD
Has Perjured Herself!**

Edward C. Noonan, Founder and National Committee Chairman of the [American Resistance Party](#) has issued the following statement regarding the hearings of Justice Britt Kavanaugh.

“It is my conclusion that [Dr. Christine Blasey Ford has perjured herself](#) in the Senate Hearings. She took an oath to tell the truth and SHE DID NOT! I do NOT believe most of what she says and she DOES NOT ACT AS IF SHE WAS INDEED SEXUALLY ASSAULTED! I will present the items that

*appear to be felonious acts of perjury. **Legal Definition:***

18 U.S. Code § 1621 - Perjury generally

Whoever—

- (1) having taken an oath before a competent tribunal, officer, or person, in any case in which a law of the United States authorizes an oath to be administered, that he will testify, declare, depose, or certify truly, or that any written testimony, declaration, deposition, or certificate by him subscribed, is true, willfully and contrary to such oath states or subscribes any material matter which he does not believe to be true; or
- (2) in any declaration, certificate, verification, or statement under penalty of perjury as permitted under section 1746 of title 28, United States Code, willfully subscribes as true any material matter which he does not believe to be true;

is guilty of perjury and shall, except as otherwise expressly provided by law, be fined under this title or imprisoned not more than five years, or both. This section is applicable whether the statement or subscription is made within or without the United States.

(June 25, 1948, ch. 645, 62 Stat. 773; Pub. L. 88-619, § 1, Oct. 3, 1964, 78 Stat. 995; Pub. L. 94-550, § 2, Oct. 18, 1976, 90 Stat. 2534; Pub. L. 103-322, title XXXIII, § 330016(1)(I), Sept. 13, 1994, 108 Stat. 2147.)

So, I, Edward C. Noonan accuse Ford of the following instances of perjury:

- (1) **She could not provide a year, or month or even a day of when the assault occurred! She admits that SHE and everyone around her had been drinking so her testimony is absolutely unreliable. And, she had no reliable witnesses that also**

saw the event she claimed happened. Furthermore, she could not state where it happened (what street or what house). The basic details were mostly absent! It's either perjury for not knowing the date, or perjury for a false report.

- (2) She identified four people who she said she was. But they were unhelpful with any collaboration about the “party” or the sexual alleged assault. One of those people, a girl (at the time) named Leland Ingham Keyser denied ANY knowledge of the gathering in question. The Ford perjury here is clear.
- (3) In 2012 Ford said her therapist took notes about the sexual assault, but Britt Kavanaugh's name did not appear therein! This also proves willful perjury.
- (4) The New York Post said that Ford told The Washington Post she was upset when Trump won in 2016, because Kavanaugh was mentioned as a Supreme Court pick. But Kavanaugh wasn't added to Trump's list of possible candidates until November 2017, a full year later. Ford cannot deny the perjury shown here.

- (5) And then there is the perjury instigated by illegal-alien George Soros in this matter. **Soros is a close collaborator with Diane Feinstein:** “Sen. Diane G. B. Feinstein and her husband, along with Venture Capitalist Richard C. Blum, hold more than 10% of the stock in AVID TECHNOLOGY, INC. Such a large holding in a public company gives them effective control of the company since no move would be made by the Board of Directors without consulting with such a large shareholder.”

And this is a brief summary of AVID CORP's involvement via Puppet-master Soros:
