US Constitution:

Preamble

WE THE PEOPLE OF THE UNITED STATES, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, **DO ORDAIN** and establish this **CONSTITUTION for the United States of America.**

Art II

"I do solemnly swear (or affirm) that I will faithfully execute the Office of President of the United States, **and will to the best of my Ability, preserve, protect and defend the Constitution of the United States.**"

Art VI

"The Senators and Representatives before mentioned, and the Members of the several **State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution...**"

14th Amendment

3. No person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, **having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States,** shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

Current Oath of New Citizens:

"I hereby declare, on oath, that I absolutely and **entirely renounce** and abjure all allegiance and fidelity to any foreign prince, potentate, state, or **sovereignty of whom or which I have heretofore been a subject or citizen;** that I will support and **defend the Constitution** and laws of the United States of America against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I will bear arms on behalf of the United States when required by the law; that I will perform noncombatant service in the Armed Forces of the United States when required by the law; that I will perform work of national importance under civilian direction when required by the law; and that I take this obligation freely without any mental reservation or purpose of evasion; **so help me God. (NOT Allah!) (Allah does NOT have a son named Jesus Christ).**

All oath takers under the US Constitution take oath as per the Signature block of the Constitution:

"Done in Convention by the Unanimous Consent of the States present the Seventeenth Day of September in the **YEAR OF OUR LORD** one thousand seven hundred and Eighty seven and of the Independence of the United States of America the Twelfth. "
